

Codes and Standards Approach

Minimum Acceptable Standard


- Prescribed practices to achieve a specific and static standard of living
- Informed by common practice in housing, primarily post-WW2
- Intended to address known external conditions, based on historical and averaged data
- Changes are incremental, intentionally slow and deliberative



Weaknesses


- Unresponsive to significant or rapidly evolving conditions
- Limited ability to address unique local conditions and needs
- Does not consider impacts of enforcement or enable measurable outcomes
